Article I- To elect a moderator for the year ensuing.

Nominations were taken from the floor. A motion was made for Joan Whaley and seconded. No more nominations. Motion carried.

Article II- To act on Town Reports of the Town.

Motion made and seconded to accept as noted. Carried.

Article III- To elect all Town and Officials as the law directs.

Selectman TE 2024- Motion made and seconded to nominate Walter (Bud) Rich.

No other nominations. Motion carried and clerk cast one ballot.

Lister TE 2024- Motion made and seconded to nominate Kathy Muther. No other nominations. Motion carried and clerk cast one ballot.

Auditor TE 2024- Motion made and seconded to nominate Martha Jewett.

No other nominations. Motion carried and clerk cast one ballot

Delinquent Tax Collector TE 2024- Motion made and seconded to nominate Janet Kendall. No other nominations. Carried.

Town Grand Juror- One year- Motion made and seconded to nominate Steve Waldo. No other nominations. Carried.

Town Agent- One year- Motion made and seconded to nominate Derek Bruce. No other nominations. Carried.

Trustee of Public Funds- One year -Motion made and seconded to nominate Debby Bean. No other nominations. Carried.

Trustee of Campbell Fund TE 2024 -Motion made and seconded to nominate Orson Kendall. No other nominations. Carried.

Article IV- Shall the voters authorize a total GENERAL FUND expenditure of \$54,744.00, of which \$42,744.00 is to be raised by taxes and \$12,000.00 carried forward from 2020 year-end General Fund surplus to cover anticipated 2022 Town operating expenses? Motion made and seconded to accept. Carried.

Article V- Shall the voters approve the transfer of \$1,000.00 from the 2020 General Fund Surplus into the Building Repair Fund to meet Town Building Repair expenses? Motion was made and seconded to accept. Carried.

Article VI- Shall the voters authorize a total HIGHWAY FUND expenditure of \$90,700.00 of which \$36,700.00 shall be raised by taxes, \$19,000.00 from anticipated State Aid Revenue and \$36,000.00 carried forward from 2020 year-end Highway Fund surplus to cover anticipated 2022 Highway expenses? Motion was made and seconded to accept. Carried.

Article VII- To see what date in 2021 shall the town set for the payment of local property taxes to be paid into the Town Treasury?

Motion made and seconded to have taxes due in full on or before December 1, 2021. Carried.

Article VIII- To do any other Town business legal and proper when met not to involve expenditures of the Town. Motion made and seconded.

Laurie Fila mentioned that Japanese Knotweed is growing in our town and asked if the Town could spray. John believed the Town would need permission and will check on this. Laurie will also do some checking and let us know. There was discussion about this very invasive plant and how difficult it is to completely remove.

Motion made and seconded to adjourn at 7:32 P.M. Carried
