The meeting was brought to order at 7:00 P.M.

Comments and Concerns- Bud mentioned that Deb had taken the GMUSD ballots to Chester to be counted during our Town Meeting. Deb explained that she was unaware that there was no one to deliver them until just before the close of the Australian voting.
